Methods and materials for containment and cleaning up

Avoid dust formation. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. This product is miscible in water. Should not be released into the environment.

Large Spills: Stop the flow of material, if this is without risk. Collect dust or particulates using a vacuum cleaner with a HEPA filter. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual

contamination.

Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS.
